Payment

This fee goes toward your total cost, and the remaining final payments are due on the date specified in the invoice. A 15% late fee will be charged each day the final payment is late.

Unforeseen Circumstances

If we have to cancel the booking due to illness or any other unforeseen circumstances that affects the ability to deliver your delectable dessert, the deposit will be refunded within seven business days of notification to the customer.

Orders

We prefer at least two weeks notice for all orders. We will however, except short notice request depending upon the intricacy of the cake and date needed. Any inspiration from photos created by another cake maker, will only be considered inspiration and will NOT be an exact replica of the cake in the photo. By placing an order with us you agree to give us creative freedom. Rest assure, we will do our best to design your cake the way you like it.

Postponement
